The Non-Metro Area Agency on Aging (NMAAA) is seeking one or more Technical Assistance Providers with expertise in federal Older Americans Act (OAA) programs. The Technical Assistance Providers would offer the following services on an as-needed basis, as directed by NMAAA:

- Assist with annual assessments of subcontracted aging service providers.
- Assist with education, training and professional development for the NMAAA Advisory Council, subcontracted aging services providers, and NMAAA staff.
- Provide operational support and guidance to subcontracted aging service providers, including but not limited to OAA service delivery, nutrition programs/menu analysis, capital outlay, consumer assessments, Wellsky unit reporting, expenditure reporting, budget development and monitoring.
- Assist subcontracted aging service providers with outreach, marketing, fundraising, and development of innovative services.
- Assist NMAAA directly with best practices; marketing/fundraising; policy development/revisions; Area Plan development, revisions, and monitoring; and innovative services.

NMAAA will reimburse Technical Assistance Providers for mileage and travel expenses at federal GSA rates.


