- [Dental Clinician Educator Career Development Program](#)

Purpose: The purpose of this program is to strengthen the primary care workforce by supporting the academic career development of dental faculty [Doctors of Dental Surgery (DDS), Doctors of Dental Medicine (DMD), Dental Hygienists (DH)] who teach primary care dentistry (general dentistry, pediatric dentistry or dental public health) and primary care physicians (MD, DO).

Eligible Applicants: Eligible applicants include domestic accredited schools of dentistry, public or private nonprofit hospitals, or public or private nonprofit entities which the Secretary has determined are capable of carrying out such grant or contract such as an academic health center which holds its own accreditation for a primary care dental residency program. Domestic faith-based and community-based organizations federally recognized Indian tribes and tribal

organizations are also eligible to apply, if otherwise eligible. The applicant institutions must be accredited by the Commission on Dental Accreditation (CODA) at the time of this application.

YouthBuild is a community-based alternative education program for youth between the ages of 16 and 24 who left high school prior to graduation that also have other risk factors, including being an adjudicated youth, youth aging out of foster care, youth with disabilities, migrant farmworker youth, youth experiencing housing instability, and other disadvantaged youth populations.

Eligible Applicants: Eligible applicants for these grants are public or private non-profit agencies. These organizations include rural, urban, or Native American/Tribal entities that have previously served opportunity youth in a YouthBuild or other similar program.
