


Request for Qualifications FY 24-07

Social Workers, Case Managers, Community Health Workers Posted April 1, 2024

The North Central New Mexico Economic Development District's (NCNMEDD) Non-Metro Area Agency on Aging (NMAAA) is seeking experienced Social Workers, Case Managers, and Community Health Workers to work throughout New Mexico, except in Bernalillo County, with our Case Management program for older adults (60+). Specifically, under the direction of the NMAAA Lead Case Manager, qualified applicants will be assigned to work directly with older adults who have significant challenges remaining independent at home as they age. This position is responsible for conducting in-home needs assessments, developing individualized care plans, and assisting clients/caregivers to obtain needed services and supports. The scope of services will vary by assignment but may include the following:

- Within the given timeframe, using the NMAAA assessment tool and related forms, conduct indepth assessments for identified vulnerable older adults to determine the level of care needed for the client to remain living safely at home.
- Develop and implement care plans and referrals for appropriate in-home and community-based services, supports, and resources.
- Advocate and assist client in obtaining forms, completing applications and paperwork, and contacting providers on behalf of client and/or caregiver.
- Follow up on care plan goals and objectives to assure positive outcomes.
- Work with clients, family members, and caregivers to ensure involvement, understanding, and approval of the plan of care.
